Giving 101: Benefits of a Qualified Charitable Distribution

Can Wisconsin's Green Fire and I both benefit if I donate to WGF from my Individual Retirement Account?

Yes, yes, yes! And there is an easy method. More and more WGF members are catching on to this opportunity, so consider joining the party!

It's called a Qualified Charitable







Distribution (QCD). It goes directly from your IRA to WGF, and you can use this method every year to make charitable gifts of up to \$100,000 per person.

For those of us who hold an IRA and are older than 70, early each year we are told how much we need to withdraw as a Required Minimum Distribution (RMD), which is generally treated as taxable income. However anyone required to make an RMD may use a Qualified Charitable Distribution to satisfy all or part of their RMD requirement, and avoiding taxes on the gifted amount. So, both WGF and the donor benefit.

Because this year's RMD is based in part on the value of your IRA account <u>last</u> December 31st, many people have discovered that their 2022 RMD is significantly higher than it was in 2021, despite the stock market having

taken some large losses recently.

An increasing number of WGF members have taken advantage of the QCD method to satisfy part or all their RMD, helping WGF in the process.

Consult your financial advisor or attorney to consider your options, and if you decide to use the QCD method, set the wheels in motion by early December to make sure there is time for the process to be carried out.

The 50th anniversary of the 1972 federal Clean Water Act (CWA) was October 18th. In celebration of this anniversary, many WGF members have shared their reflections, experiences, and insights into how the CWA has positively affected water quality and water policy across Wisconsin.

Bruce Neeb, WGF member and Wisconsin Department of Natural Resources retiree who served 27 years with WDNR's Information/Education (I&E) and Grants and Loans programs, wrote a <u>short piece</u> on his experiences seeing the CWA protect water and communities in western Wisconsin. "When it comes to clean water, it's best to act before we pay the cost in terms of human lives."
