


### WI Gray Wolf Events in 2022 and WGF

- Gray Wolves returned to Federal ESA list on February 10, 2022 across much of US
- Winter track surveys complete by April 1, 2022
- WGF social and fund raisers for wolf conservation with Louis Family on Lake Owen July 25, 2022
- WGF field event in Cable August 4-5, 2022, including successful howl for wolves.
- WDNR announced new wolf population estimate for 2022 on Sept. 30; decline of 14% from 2021.
- International Wolf Symposium, Oct. 13-16; 3 talks by WGF wolf team
- WDNR announced draft of new wolf plan on Nov. 10; many WGF recommendations included.

## Positive Aspects to Draft WI Wolf Plan

- Removal of Numeric Goal; no need to reduce to 350 wolves
- Focus on Sustainable Populations and Ecological Benefits especially in Core Wolf Areas (Zones 1, 2 &5)
- Create protective Buffer Zones around Indian Reservations
- Modify 6 zones across the state to better protect populations and allow better control in Areas with High Conflicts
- Emphasis on Education and Teaching People about the State Wolf Population
- Emphasis on Reducing Illegal Wolf Kills
- Strong Commitment to Science and Continued Research with Partners

### Some Areas of Concern with Draft Wolf Plan

- Plan calls for Lower Permits per Wolf Quotas to reduce risk of over-harvest and provide longer wolf seasons. If season too long could become disruptive to wolf packs, and reduce effectiveness of track surveys
- Propose training for wolf hunting dogs that would begin after firearm deer season, and would end after all wolf zones are closed to harvest. Same concerns as above.
- Does not create separate science and stakeholder advisory committees, and not clear who will be able to serve on the state wolf advisory committee

# Things DNR Cannot Change in Wolf Plan

- Decision to Close Any Part in the State to a Wolf Hunting and Trapping Season
- Eliminate Use of Dogs in Wolf Hunting
- Change Start Date or Possible End Date of Wolf Harvest Except when Quotas Have been achieved in any Wolf Zone
- Eliminate Compensation for Dogs or Livestock
- Cannot Close Zones to Harvest until after 24 Hour Notification
