# Fred Clark Announces Retirement, Meleesa Johnson is WGF's New Executive Director!

It had to happen sometime...

Fred Clark is retiring as executive director of Wisconsin's Green Fire.

Fred will remain active with Green Fire while he spends more time outdoors on land and on water.

During Fred's five years as WGF's first executive director, he and the teams of researchers in our Work Groups published papers on gray wolves, PFAS "forever" chemicals, energy policy, wetlands, and other significant issues for Wisconsin's lands and waters.

He took a young nonprofit and shaped it into a statewide leader on natural resource science and policy. He leaves Green Fire in good shape and ready for the future.

Starting November 1st, our next executive director is Meleesa Johnson. Meleesa is no stranger to Green Fire as she has been deeply involved in the PFAS ("forever" chemicals) issue through the Contaminants of Emerging Concern Work Group. She presented at WGF's statewide conference "PFAS in Wisconsin" in June of this year.

Meleesa lives in Stevens Point where she served six years as city council president and on the Portage County Board where she represented the

county to the Wisconsin Legislature. She led strategic planning, created a housing task force, drafted policies and ordinances, and developed the legislative language for the County's first Diversity Affairs and Inclusion Committee. She is a dedicated conservationist.

She started college at 40 and graduated summa cum laude at 45 from the University of Wisconsin-Green Bay. Having been a nontraditional student herself, she is committed to mentoring and building capacity in others through mentoring and developing internship programs like WGF's Conservation Pathways program.

As a member of one of Green Fire's Work Groups and the <u>Science</u> <u>Council</u>, she sees firsthand the expertise and depth of our team of scientists that research our state's most pressing issues. She recognizes the value of science-informed decisions and is an excellent public speaker.



## **Update on TWA Wolf Ecology Weekend**

It's Wisconsin Wolf Awareness Week October 15-21, 2023!

Wisconsin's Green Fire sponsored the <u>Timber Wolf Alliance (TWA) Wolf Ecology Weekend</u> in August. **Melanie Michaels**, TWA Coordinator, provided this summary about the event:



The Timber Wolf Alliance Wolf Ecology Weekend is an annual event that takes place the third weekend in August. This year, nineteen participants from five different states joined together at the historic Forest Lodge in Cable, Wisconsin, to learn about wolf ecology, the Ojibway connection to wolves, and wolf management in Wisconsin. During the three-day workshop, participants found signs of a wolf pack and even heard one wolf howling in the distance.
