WGF Joins Nitrate Watch Program (You can too!)

WGF is now a partner of the Izaak Walton League's Nitrate Watch program! This people-powered community science program allows anyone to help gather data about nitrate in Wisconsin's waters. Nitrate is the most common chemical contaminant creating health risks in Wisconsin's private wells. It also harms the water quality and ecological health of our lakes, streams and rivers.

Free of charge, anyone can **sign up for a kit of 25 strips** to test their own or their neighbors' private wells, their city water supply, or any lake, stream or river they care about. Testing is easy and quick - **click here for more info and tutorial videos!** List Wisconsin's Green Fire as your organization when you sign up so we can summarize the data from all around the state. As you can see from the map to the right, Wisconsin has some data but could use a lot more!

Wake Boat Bill Expected Soon

Last week, we shared a new study from the <u>University of Minnesota</u> that shows how wake boats impact lakes, especially below the surface. The study **affirms our earlier recommendation** to limit wake boat use in waters less than 20 ft deep because of the dramatic impacts to the water column, fish, aquatic plants,



and sediments in the lakebed.

Now, we hear it's go-time in the Wisconsin Assembly. Sources indicate that a bill favored by the wake-boat industry is expected in the Assembly in early September, with possibly very short notice for a public hearing in Madison.

The Wakesports Reform Coalition anticipates this bill would not adequately protect Wisconsin's lakes and rivers from the negative impacts of wakeenhanced boating.

We do not yet have the exact language of the bill, but we will share it with you when it is available. We encourage you to attend the hearing (date/time pending) and contact your elected leaders. This is a powerful time to use your voice for conservation!

Enbridge Line 5 Pipeline Update

The contested case hearings on the Wisconsin Department of Natural Resources (WDNR) water permits for the Enbridge Line 5 oil pipeline reroute in Wisconsin began August 12 in Ashland, Wisconsin.

As you may remember, the permits for the pipeline's proposed reroute around the Bad River Reservation have been legally contested by multiple groups. Among the concerns are how the pipeline would impact wetlands, waterways and important sensitive species like manoomin.


